

ON CAMPUS STUDENT LOT SMHS PARKING PERMIT APPLICATION 2024-25 SMHS PARKING REGULATIONS:

1. All student vehicles parked on campus must have the current SMHS **parking permit affixed to the front windshield** (inside lower left corner).
2. A **Start Smart** class must be completed before applying for a SMHS parking permit (no exceptions).
3. All students are required to show a driver's license, current proof of insurance and current DMV registration. Priority will be given to Seniors, then Juniors and Sophomores (based on permit availability).
4. **Parking privileges can be revoked by the administration at any time due to unsafe driving, poor attendance, excessive tardies, and/or disciplinary infractions.**
5. Students are prohibited from sharing or loaning their permit to other students. Violations will result in disciplinary action.
6. Replacement of permit (for any reason) will result in a **mandatory 30 day waiting period** before a new permit will be issued with a \$20.00 fee. Second replacement of permit will result in loss of parking privileges for the remainder of the school year.
7. Parking is limited to the designated student parking lot area—**NOT THE STAFF PARKING LOT at the front of school on San Marcos Blvd.**
8. SMHS assumes no responsibility for any damages that may occur while student vehicles are parked on or off campus.
9. Speed limit is 5 MPH, which is strictly enforced. Any form of reckless driving will result in disciplinary action/loss of parking privileges.
10. Students are prohibited from loitering in the student parking lot during school hours, including before and after school.
11. Students may not access vehicles during school hours. Vehicles may not be used as lockers.
12. Vehicles are subject to search by site administration and law enforcement at any time.
13. Illegally parked vehicles are subject to ticketing or towing at the owner's expense.
