## Fee Waiver Eligibility

Dear Parents and Guardians,

Fee waivers are resources provided by College Board and ACT that exempt 11th and 12th grade students from paying registration fees associated with the SAT and ACT. Students may receive a lifetime maximum of two (2) fee waivers per test for the SAT and ACT for total of four (4) waivers. Additionally, you may have access to free score reports, college application waivers and more. Details are available on the attached FAQ sheet and the SMHS College and Career website.

**IMPORTANT:** San Marcos High School only receives a certain number of fee waivers based on the number of students that used them the prior year. If a student registers with a fee waiver but DOES NOT sit and take the test, San Marcos High School will lose that fee waiver for the following year.

Please see the guidelines below and check the box that best identifies your student. Upon approval, the student is required to immediately register online with the Career Center technician as the waiver can not be used outside of SMHS.
