### SAN MARCOS HIGH SCHOOL PARKING REGULATIONS

- All student vehicles parked on campus must have the current SMHS
   parking permit affixed to the front windshield (inside lower left corner).
- 2. A "Start Smart" class must be completed before applying for a SMHS parking permit (no exceptions). Times and dates can be found on our school's website. Not required for the 2021/22 school year.
- 3. All students are required to show a driver's license, current proof of insurance and current DMV registration. Priority will be given to Seniors, then Juniors and Sophomores (based on permit availability).
- 4. Parking privileges can be revoked at any time by the administration.
- 5. Students are prohibited from sharing or loaning their permit to other students. Violations will result in disciplinary action.
- 6. Replacement of permit (for any reason) will result in a **mandatory 30 day** waiting period before a new permit will be issued with a \$20.00 fee. Second replacement of permit will result in loss of parking privileges for the remainder of the school year.
- 7. Parking is limited to the designated student parking lot area.
- 8. SMHS assumes no responsibility for any damages that may occur while student vehicles are parked on campus.
- 9. Speed limit is 5 MPH, which is strictly enforced. Any form of reckless driving will result in disciplinary action/loss of parking privileges.
- 10. Students are prohibited from loitering in the student parking lot during school hours, including before and after school.
- 11. Vehicles may not be used as lockers.
- 12. Vehicles are subject to search by site administration and law enforcement at any time.
- 13. Students receiving permits agree to follow these rules and understand the consequence may result in loss of parking privileges.
- 14. Illegally parked vehicles are subject to ticketing or towing at the owner's expense.
